Subject: Student Achievement Outcome Data

The following information is provided for you in accordance with the Accreditation Commission for Education in Nursing, Inc. criteria, and the Student Right to Know and Campus Security Act, formulated by the United States Department of Education.

1. Graduate Success on NCLEX-RN Licensure Exam

Expected Level of Achievement: - Annual licensure examination pass rate will be at least $\geq 80\%$ for all first-time test takers and repeaters during the same 12-month period

2. Program Completion Rate

Expected Level of Achievement: $\geq 60\%$ of students who are admitted to the program will successfully complete the program on-time from the first nursing course through the last nursing course on-time in 4 semesters required for conferral of a certificate, diploma, or degree. The completion rate is based on 2 years of attendance that equals 100% of the length of our standard program.

3. Job Placement

Expected Level of Achievement: 90% of graduates will report working as a Registered Nurse within 6-9 months after graduation.

Student outcomes for the Classes of 2024, 2023, and 2022 are as follows:

Class of 2024

- The program completion rate for students entering in fall 2022- 95%.
- NCLEX-RN First Time Pass rate- 86%.; Ultimate Pass rate- 95%; New York State Pass rate -87.5%
- 100% of those responding to survey post-graduation (43/45) are employed as Registered Nurses.

Class of 2023

- The program completion rate for students entering in fall 2021-62.5%.
- NCLEX-RN First Time Pass rate-86%. Ultimate Pass rate- 98%; New York State Pass rate-79%
- 100% of those responding to post-graduation surveys (41/53) are employed as Registered Nurses.

Class of 2022

- The program completion rate for students entering in fall 2020-52%.
- NCLEX-RN First Time Pass rate is 65%. Ultimate Pass rate is 82.5%; New York State Pass rate-73.7%
- 100% of those responding to post- graduation surveys (27/40) are employed as Registered Nurses.

End of Program Student Learning Outcomes Data

End of Program Student Learning Outcomes (EPSLOs) embody the knowledge, skills, behaviors, and attitudes necessary of the student, upon graduation, to display readiness for the National Council Licensing Examination (NCLEX-RN) and entry level practice as a Registered Nurse in New York. The EPSLOs also reflect the mission and philosophy of the nursing program. They frame a curriculum that supports diversity, culture, and inclusivity and prepares a graduate who is able to serve the healthcare needs of a culturally and ethnically diverse population, in a sensitive manner. The EPSLOs also reflect readiness for furthering one's education in a bachelor program of study to attain a Bachelor Degree in Nursing (BSN).

End of program student learning outcomes are the impetus from which the nursing courses develop Course Student Learning Outcomes (CSLOs). Faculty design learning activities and modules to assist students in meeting Course Student Learning Outcomes. These CSLOs are leveled, from simple to complex, as the student progresses through the 2-year curriculum. In the final course in the nursing program, Nursing 2600, students participate in a number of assignments, preceptorship, clinical performance testing, projects, and standardized examinations to demonstrate competencies and provide aggregated data to determine to what level of achievement the End of Program Student Learning Outcomes were met.

All students completing this program are expected to have achieved the following learning objectives:

1. Integrates theoretical knowledge of nursing and implements patient-centered nursing care through interdisciplinary teamwork, therapeutic communication, clinical judgment, standards of safe care, and the nursing process.
2. Model professional standards of practice within an ethical legal framework to provide safe, competent, quality care.
3. Demonstrate a commitment to the nursing profession by analysis of personal growth and professional development while functioning to achieve and promote desired health outcomes.
4. Facilitate communication with patients, families and communities through the use of informatics and technology in the healthcare system to provide established standards of care that incorporate evidence-based professional practice.
5. Integrates patient-centered care for a diverse population across the life span utilizing knowledge from the sciences and critical thinking to promote safe and competent nursing care.
